## **Statement of Service Performance**

## **Christchurch Junior Cricket Association Incorporated** For the year ended 31 July 2024

'What did we do?', 'When did we do it?'

### **Description of Entity's Outcomes**

Outcome - To maintain and grow the numbers of children playing by providing fun, meaningful cricket experiences. Output - Co-ordinate pre-season and on-going awareness programs in schools and community settings and deliver appropriate competitions and festivals.

Outcome - To provide quality governance, leadership and administration

Output - Brand development, advice and support of clubs, prudent financial management and identification of possible additional revenue streams, legislative compliance, collaboration with other cricket entities, effective communication with stakeholders, clubs, players and parents.

Outcome - To invest in the capability of our people in order to increase the quality of the cricket experience provided. Output - Ensure coaching qualification and education opportunities are available via clubs or via partnership with CMCA staff. Provide support to club administrators. Provide opportunities for players to gain a basic umpire qualification prior to leaving CJCA cricket and also facilitating the use of Youth cricketers to umpire in Festivals. Ensure Best Practice is followed in terms of Athlete Development and "Balance is Better" and "Good Sports" principles are incorporated into all competitions, programs and events.

## **Description and Quantification of the Entity's Outputs**

2024	2023
October 2023 saw the establishment of a team of Game Development Officers (GDO's) who were tasked with "Growing the Game" by delivering "awareness" type sessions year round with specific focus on the School Term 3 - these Officers are employed by Canterbury Cricket but work in the Christchurch Metropolitian area. This resource was in place late in Term 3 2023 but had little time to deliver programmes pre-season which could have contributed to the decline in player numbers in the 2023/24 season. This new resource resulted in a decline in the funding previously provided by New Zealand Cricket and Canterbury Cricket that the CJCA previously used to fund Clubs to deliver these type of Programmes or arranged as an Association for Clubs unable to deliver themselves. Some Clubs still decided to deliver this at their own cost but this generally meant a decline in the financial activity in terms of both Income and Expenditure for the Association. As well as delivering specific programmes focused on the disabled community "All Abilities Cricket" and "Girls Smash" - (a mid week Girls skills and playing opportunity at a number of neighbourhood parks) the GDO's are tasked with assisting with Club based Coach Development opportunities and building an understanding of clubs allocated to each of them.	Approximately 8139 children delivered to in pre-season Awareness Programs from 49 schools. On-going delivery by both Clubs and arranged Contractors making connections to clubs for play and membership opportunities.
198 teams at the start of the 2023/24 season and 178 at the end with year 8 players moving to Youth. Approximately 1,599 players in CJCA competitions and 373 players in pre-competition programmes at 9 clubs	222 teams at the start of the 2022/23 season and 202 at the end with year 8 players moving to Youth. locally to remove a barrier for some schools. The CJCA hosted two major Regional Festivals in the 2023/24 season - the Boys Tier 1 Festival featured 8 teams including 3 from the CJCA - this was hosted at the Burnside West University Cricket Club. It also hosted the annual Christchurch Girls Festival which attracted 8 teams again with 3 CJCA teams and club team from Christchurch (Halswell) participating. Youth Boys and Girls were used to umpire at these Festivals.	and girls held in School time during Term 4 and 1 with many novice cricketers exposed to the game. This figure was down on previous years due to continued pressures on Schools in terms of compliance and availability of cover staff.
A Pre-season Training Programme delivered to over 220 Year 6-8 boys and girls.	A Winter Training Program delivered to over 200 Year 6-8 boys and girls.

## **Statement of Accounting Policies**

## **Christchurch Junior Cricket Association Incorporated** For the year ended 31 July 2024

'How did we do our accounting?'

### **Basis of Preparation**

Christchurch Junior Cricket Association Incorporated has elected to apply PBE SFR-A (NFP) Public Benefit Entity Simple Format Reporting - Accrual (Not-For-Profit) on the basis that it does not have public accountability and has total annual expenses of equal to or less than \$2,000,000. These statements have been compiled using the PBE Tier 3 standards for Charities. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future. Amounts are presented in New Zealand Dollars and are rounded to the nearest dollar.

## Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

#### **Income Tax**

Christchurch Junior Cricket Association Incorporated is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

#### **Bank Accounts and Cash**

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

## **Changes in Accounting Policies**

There has been no change in accounting policies. All policies have been applied on a consistent basis with those of the previous reporting period.

## **Revenue Recognition**

Grants/Donations income is recognised as income on receipt unless the association has a liability to repay if the requirements of the grant or donation are not fulfilled. A liability is recognised to the extent that such conditions are unfulfilled at the end of the reporting period.

Interest revenue is recorded as revenue in the period it is earned.

Tournament fees/Parent Contributions are recorded when paid as they are due prior to the start date of any tournament

Player levies are recognised when they are invoiced to the clubs and are payable before the end of the season which aligns with the financial year

CCA Funding is accounted for in the period that it relates to

### Inventory

Inventories are stated at the lower of cost and net realisable value. Costs have been assigned to inventory quantities on hand at balance date using the first in first out basis.

### Investment

Investments are term deposits recognised at cost.

## Plant Property and Equipment (incl depreciation)

Property, plant and equipment are stated at cost less accumulated depreciation. Depreciable assets are depreciated on the diminishing value method at rates determined by the Inland Revenue Department under the Income Tax Act 2007. The following rates were used:

Motor Vehicles - 10% Computer Equipment – 20%-50%

Christchurch Junior Cricket Association Incorporated paid Abhimanyu Shrikhande (the Treasurer) an honorarium of \$2,000 (last year: \$2,000). No payments were outstanding as at the balance date (last year: nil)

Christchurch Junior Cricket Association Incorporated paid Robin Wilkinson (the general manger) an advance for his KPI bonus for \$0 (last year \$1,000). No amounts are outstanding as at the balance date (last year: \$600)

Christchurch Junior Cricket Association Incorporated paid Cat Quinn who is a committee member is contracted as an operations assistant \$12,484 (last year: \$15,126) No payments were outstanding as at the balance date (last year: nil)

# INDEPENDENT ASSURANCE PRACTITIONER'S REVIEW REPORT TO THE MANAGEMENT COMMITTEE OF CHRISTCHURCH JUNIOR CRICKET ASSOCIATION INCORPORATED

### Report on the Performance Report

We have reviewed the accompanying performance report of Christchurch Junior Cricket Association Incorporated (the Society) which comprises the entity information, the statement of service performance, the statement of financial performance, and statement of cash flows for the year ended 31 July 2024, the statement of financial position as at 31 July 2024, and the statement of accounting policies and other explanatory information.

### Management Committee's Responsibility for the Performance Report

The Management Committee is responsible for the preparation and fair presentation of the performance report in accordance with Public Benefit Entity Simple Format Reporting - Accrual (Not-for-profit) ("PBE SFR-A (NFP)"), and for such internal control as the Management Committee determine is necessary to enable the preparation of a performance report that is free from material misstatement, whether due to fraud or error

### Assurance Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying performance report. We conducted our review in accordance with International Standard on Review Engagements (New Zealand) (ISRE (NZ)) 2400, Review of Historical Financial Statements Performed by an Assurance Practitioner who is not the Auditor of the Entity ("ISRE (NZ) 2400"), and our review of the entity information and the statement of service performance in accordance with the International Standard on Assurance Engagements (New Zealand) ISAE (NZ) 3000 (Revised), Assurance Engagements Other than Audits or Reviews of Historical Financial Information. Those standards require us to conclude whether anything has come to our attention that causes us to believe that the performance report, taken as a whole, is not prepared in all material respects in accordance with PBE SFR-A (NFP). Those standards also require that we comply with relevant ethical requirements.

A review of the performance report in accordance with ISRE (NZ) 2400 and ISAE (NZ) 3000 (Revised) is a limited assurance engagement. The assurance practitioner performs procedures, primarily consisting of making enquiries of management and others within the Society, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less than those performed in an audit conducted in accordance with International Standards on Auditing (New Zealand) and ISAE (NZ) 3000 (Revised) Assurance Engagements Other than Audits or Reviews of Historical Financial Information. Accordingly, we do not express an audit opinion on this performance report.

Other than in our capacity as assurance practitioner we have no relationship with, or interests in, the Society.

## Conclusion

Based on our review, nothing has come to our attention that causes us to believe that:

- a) the reported outcomes and outputs, and quantification of the outputs to the extent practicable, in the statement of service performance are not suitable;
- b) the performance report does not present fairly, in all material respects the financial position of the Christchurch Junior Cricket Association Incorporated as at 31 July 2024, and the entity information, service performance, financial performance, and cash flows for the year then ended in accordance with PBE SFR-A (NFP).
